### **DATES**

Application Deadline: March 15, 2025

All applications must be timestamped on or before March 15. Late applications will not be considered.

Internship Start Date: January 2026

Exact date will vary based on intern's availability and start dates of other students in CCHMC's Division of Child Life and Integrative Care. We aim to give interns a cohort for peer support during their internship

## **APPLICATION PROCESS**

Applicants will be notified via email when their complete application has been received. Incomplete applications will not be reviewed.

The top applicants will be contacted via email to schedule a virtual interview.

### **Current Resume**

Outlining relevant academic, professional, and volunteer experiences

### **Essays**



A document with essays answering each of the following:

- 1) Why did you decide to pursue a career in music therapy? What areas of music therapy practice interest you the most?
- 2) What are your strengths as a student music therapist?
- 3) What skills do you hope to refine during your internship?
- 4) Why are you interested in interning in a mental health setting with children and adolescents? How will this internship help you achieve your career goals?

Please answer questions 5 & 6 with examples of interactions, experiences, or observations that focus on diversity, equity, inclusion, and/or accessibility (DEIA).

- 5) How have you been impacted by DEIA?\*
- 6) How do you foresee integrating DEIA into your interactions with patients, families, and staff in the mental health setting?\*

\*Please note that the essays for questions 5 & 6 will also be blind reviewed by members of CCHMC's Child Life and Integrative Care's DEIA Collective to determine eligibility for a DEIA Scholarship.

### Video

A video showcasing the applicant's skills on:

- Guitar
- Piano
- Voice

Applicants should play 3 songs that are relevant to individuals between ages 5 and 17 in a mental health setting. Do not submit mock music therapy experiences/interventions.

Submit the video via a YouTube link. Video should be uploaded as an *unlisted* (not private) YouTube video. For more information, see <u>this website</u>. Please include the YouTube link in the document with the essays.

# **Coursework Description**

A PDF or website link explaining the music therapy curriculum at applicant's university. If sending a link, please include the link in the document with the essays.

# **Electronic Transcripts**



Submit transcripts from all universities attended. Official or unofficial transcripts will be accepted for the application process. If selected for internship, applicants will need to supply official transcripts as part of the acceptance process.

### 3 Letters of Recommendation

Letters should be written by individuals familiar with the applicant in a professional, academic, or volunteer environment. Letters should address applicant's musical, clinical, and professional skills. Recommendations should be emailed directly from the writer to mentalhealthMTinternship@cchmc.org

# Letter of Eligibility from Academic Director

The statement of eligibility can be included in a letter of recommendation if the director is writing one. Otherwise, it should be a separate letter in addition to the 3 letters required above. It should be emailed directly from the director to mentalhealthMTinternship@cchmc.org
